## SUMMER FINANCIAL AID APPLICATION ELIGIBILITY INFORMATION CENTRAL MICHIGAN UNIVERSITY

The following criteria apply to **summer aid eligibility**:

1. Students must be enrolled in a degree program at CMU; guest students and non-degree students are not eligible for aid.
2. Only CMU credit hours will be considered in determining eligibility.
3. Students must be making satisfactory progress toward a degree (CMU's policy is available at our web site: [www.financialaid.cmich.edu/sa.shtml](http://www.financialaid.cmich.edu/sa.shtml)). If you are currently on financial aid suspension, your eligibility for summer financial aid will be determined after your spring semester progress has been assessed.
4. For priority processing, students must file this form with the Office of Scholarships and Financial Aid by May 1 (including students whose enrollment starts after May 15).
5. For timely receipt of financial aid documents, students should update their local mailing address through the student portal (<https://portal.cmich.edu>). All correspondence will be mailed to your CMU global ID email account.
6. Students must have on file a Free Application for Federal Student Aid (FAFSA) for the current academic year and all other requested documents relating to the application. If you have not previously filed a FAFSA for the current academic year, it must be received by CMU no later than May 1.
7. **Students are responsible for payment of educational expenses (including late fees) until aid is disbursed.**
8. If we receive information from the federal database indicating that you have exceeded your annual maximum aid because of aid received at another institution you will be required to return all or a portion of the aid received from CMU.
9. Pell Grant applicants must have remaining eligibility for the current academic year and must be enrolled in a minimum of 3 credit hours.
10. Direct Loan applicants must have remaining eligibility for the current academic year. Undergraduate students must be enrolled in a minimum of 6 credit hours for summer; graduate students must be enrolled in a minimum of 5 credit hours.
11. Federal Work Study applicants must file the FAFSA that applies to next academic year and submit requested documentation.

### PAYMENT DATE

Payment of financial aid is based on your enrollment status. For most financial aid programs you must be enrolled at least half-time (6 credit hours for undergraduate students and 5 credit hours for graduate students). Summer financial aid will be disbursed when your enrollment status is at least half-time, but not sooner than the beginning of the Summer session. If you add or drop classes after the disbursement of your aid, your aid is subject to revision. **Federal aid will be cancelled for any student who drops below half-time.** If you add an additional class after your aid has disbursed, you will need to pay for the class with your summer financial aid refund.
